For each visitor to our Web site(s), our Web server automatically recognizes only the visitor's domain name, but not the e-mail address (where possible).

With respect to cookies: We use cookies to record session information, such as user-specific information on what pages visitors' access or visit.

With respect to Ad Servers: We do not partner with or have special relationships with any ad server companies.
